Exhibitor Set-Up & Tear Down

Set-up is Thursday, July 16 from 1:00pm – 4:00pm in MAGNOLIA FOYER FG.

Please note, you must be fully set by 4pm. “Meet and Greet” with Exhibitors in Magnolia ABC starts at 4:30pm. Exhibitors are invited to attend the Thursday “Cases and Cocktails” 5:30pm - 6:30pm.

We ask that all ACHD displays remain until Saturday, July 18th at the closing of the ACHD educational session (5:40pm). We ask that you do tear down after the Saturday educational session. Materials and/or displays remaining in the exhibit area which are not packed and labeled for shipping may be disposed of.

Once your boxes are packed/labeled for shipment on Saturday, you can leave on your table and Omni staff will handle getting them to the package pick up area. Please remember to bring your packing tape!

EXHIBITOR PREFERENCE
